Acute Exposure:

4. FIRST AID MEASURES

Steps to Be Taken in Case Material Is Released or Spilled:

Barricade the area to restrict access. Remove ignition sources. Use non-sparking tools.

SMALL SPILL: Absorb the liquid with inert material (such as dry sand or earth) and place it in a chemical waste container.

LARGE SPILL: Persons not wearing protective equipment should be evacuated from area of spill until cleanup has been completed. Stop leak at source when it is safe to do so. Dike and pump the liquid into waste containers. Prevent spilled material from 1) contaminating soil, 2) entering sanitary sewers, storm sewers, and drainage systems, and 3) entering bodies of water or ditches that lead to waterways.
